# "MASONRY UNITED"

I am really amazed at the demand for this year's Grand Master's pins that bear the words, "Masonry United.'

I would like to take a moment to explain the origin and the intent of these words.

I became a Mason in November, 1969, in Piedmont, and since then, I have become a member of the Eastern Star, York Rite, Red Cross of Constantine, Scottish Rite, Shrine, Grotto and Royal order of Scotland

I'm not mentioning these organizations for any personal recognition, but rather to explain that I have a pretty good working knowledge of a number of Masonic bodies. After I was elected as



a Grand Lodge officer, I began looking around and found there was one concern among all the Masonic bodies. That concern was, of course, membership. The Shrine was worried about Shrine membership, and the York Rite was concerned with membership in those bodies. The same was true with the Eastern Star and Scottish Rite.

After talking with a friend and brother from Kansas, I found that his Grand Lodge had conducted a program to bring together all the Masonic bodies into one large force to improve membership. The concept is so simple. As Blue Lodge Masons, we are not allowed to invite people to join our organization. With this taken into consideration, isn't there a better way of doing things? I believe that if our appendant bodies (including the Shrine) will join in a cooperative effort to recruit members, it is bound to have a positive effect. Just look around. The York Rite Bodies have their colorful coats, hats (Chapeaus) and regalia, the Scottish has its own brand of uniforms, as does the Shrine. For instance, when the Scottish Rite does its children's shoe program, the members should always be on the alert for any prospective Masonic

If the answer is in the affirmative the Shriner should have a petition on hand and explain the Masonic

If one of the ladies know a friend or neighbor whose husband would be a good Mason, they can simply ask the husband, or have his wife do it. My late wife, Carol, found more than one candidate who has proven himself to be an outstanding Mason.

All the women's and youth organizations can be equally effective, and I plan to offer each of them an opportunity to join in this effort.

As I travel across the state, I want to carry this message to our Blue Lodges and each of our appendant bodies. Together, working as a team, we can make a difference.

## Social Media and Freemasons

Having recently attended the Conference of Grand Masters of North America held in Baltimore, MD., I had the opportunity to attend a "Breakout Session" on the topic of "Social Media & Grand Lodges." Assuming that something was to be learned on how Grand Lodges could take advantage of the various social media sites, I enthusiastically headed for the meeting room where the class was to be held. In only a few minutes after I was seated, the Moderator started and a few minutes later the realization that this was not what I "assumed" it to be settled in.

Instead of how the Fraternity could benefit from social media, the Brethren in the room were discussing the abuses! How members in various Grand Lodge Jurisdictions were posting photographs depicting scenes and behavior that was anything but Masonic, making slanderous comments about Brother Masons, revealing topics that were discussed in a tiled lodge meeting, etc., etc.. One Grand Lodge Officer told of a Brother, when warned that what he was posting was unacceptable, telling him that he could not infringe

on his right to "free speech." Being technology backward I did not realize that this sort of thing was going on as I am not into facebook, twitter or any of the other social media sites. To me cell phones, email and texting are still a wonder! I have no doubt that in 24 months my 2-1/2 year old grandson will exceed my abilities in all things electronic.

Back to the discussion. After 45 to 50 minutes the general consensus was that the various Grand Lodge Jurisdictions needed to adopt "Social Media Guidelines" so that the Brethren might know what is acceptable behavior on the internet. After agreeing with the "guidelines was a good idea," it was at this point that my "two cents" were added into the mix. The opinion offered was that whether it be the spoken word, written word (as in newspaper, letter or note) or the electronic word, a Mason should know how to treat his fellow man; and should know the difference between what is acceptable behavior in our society and what is unacceptable behavior. If he does not know this then someone, somewhere did a poor job on the investigating committee! As to the Brother resting on his right to "free The Bridge Builder

speech," I reminded the group of our obligations and commitments made to the fraternity and that as far as our Craft was concerned "free speech" is restricted to the rules, laws, constitutions and guidelines set down by the various Grand Lodges. Also, that there exists, in most jurisdictions, especially the Grand Lodge of Alabama, methods and procedures to remedy any unmasonic behavior, infractions, perceived slanders or injustices.

The room fell silent, the two brothers from Kentucky gave me a thumbs up, a few nodded in agreement and the majority simply stared. Maybe it was the comment "especially the Grand Lodge of Alabama!"

The Grand Master of the Grand Lodge of Massachusetts was kind enough to send me a copy of the "Social Media Code of Conduct for Massachusetts Freemasons," part of which follows:

- A Mason should conduct his Social Media activities in a way that reflects his membership in the Craft. He should act in a way that presents a positive image of his membership in Freemasonry to the world.
- As a Mason, he must be aware that his postings are a permanent record; therefore, his conduct may influence the world with a positive or a negative opinion about him personally and also about any organizations to which he belongs.
- His actions on the various Social Media outlets should reflect the highest standards of morality and integrity he would practice within the Lodge.
- To insure our fraternity represents itself to the high standards we

believe in, we must regulate our actions through Brother-to-Brother intervention. As a Mason, you should advise a Brother if you feel that what he has posted is improper within the framework of our Grand Constitutions, rules, regulations, and edicts.

- Do not identify any Freemason as a member of the Craft unless he has provided his consent, or has already identified himself as such.
- There should never be discussion related to the application, background or investigation of an applicant.
- There should never be discussion regarding the ballot of an applicant.
   There should never be discussion related to the business of a Lodge and what is discussed within our tiled doors.

This represents approximately one-half of their guidelines. To the average person all of this is common sense and I have no doubt that the vast majority of Alabama Masons already adhere to these guidelines and more. As the social networking continues to grow there is wide concern, as evidenced in the "Breakout Session," that these kind of issues and problems will continue to become more numerous.

Being angry or being stupid is a different thing when writing a letter, you have time to rethink before it hits the mailbox. This is not so with the internet; once you push the send button it is like shooting a bullet, it can't be recalled, but unlike the bullet it stays out there for all time for someone to see!

Let us all hope and pray that Alabama Masons will not have to adopt a "Social Media Code of Conduct."
