# A MESSAGE BY VAN TIDWELL, MW GRAND MASTER

First, allow me to express my gratitude to each of my brethren for allowing me to serve as your Grand Master for the 2019 year. Thus far it has been a journey of enjoyment for my family and I to be allowed to represent our Great Fraternity within and outside of the State of Alabama. The experience has been rewarding, but humbling at the same time. Each of you know this, each time I make a decision and represent our Grand Jurisdiction of Alabama, it is keeping the Fraternity and its members best interest in mind.

As a follow up of the previous article that I wrote in the fall of 2018, I issued a challenge for the brethren to learn the Masonic Funeral Rites (as written in the Alabama Ritual Booklet). These programs need to be exhausted each year by the lodges. We all have members and their families that could benefit from these programs. Brethren, keep in mind, that it is our responsibility and obligation to assist these worthy individuals when called upon. Also, ask

# GRAND LODGE OF ALABAMA CHARITABLE OUTREACH PROGRAMS

The Grand Lodge offers a number of Charitable Programs designed to provide financial assistance for Lodges and persons who apply and meet the qualifications as outlined by the requirements of the specific program. A basic description of the Programs available this year, is provided below. **Some programs have specific requirements that must be met for the applicants to be considered.** This information along with the all forms necessary to apply for these programs, can be found on the Grand Lodge website "Charitable Outreach Programs" page at **www.alafreeMasonry.org/committees/coprog/** 

## **MASONIC SCHOLARSHIP**

The purpose for the Alabama Masonic Scholarship Program is to provide financial assistance to university, college, or technical school students. Preference will be given, but not limited, to applicants who have a father, stepfather, brother, uncle, grandfather, or step-grandfather who is, or was at the time of his death, a Master Mason in good standing in an Alabama Masonic Lodge.

Awards scholarships to eligible applicants for up to \$1000. The same individual cannot receive this grant in conjunction with Scholarship Matching Fund plan.

## SCHOLARSHIP MATCHING FUND PLAN

The purpose for this part of the Charitable Outreach Program is to provide supplemental financial assistance to Lodges under the jurisdiction of this Grand Lodge to encourage them to award a scholarship to a deserving student in their community. Local Lodges can apply for up to \$500 in matching funds on a first-come first-funded basis. Grants will not be approved to anyone receiving a COC Scholarship that year.

Matching Scholarship grants to a lodge will be for up to maximum of \$1,000 for the year. The maximum amount of money paid out per application cannot exceed \$500 and is subject to the availability of funds.

# **MATCHING RELIEF FUND**

The purpose for the Matching Relief Funds Plan is to provide supplemental financial support to Lodges under the jurisdiction of this Grand Lodge who undertakes to render monetary assistance to worthy, specifically named individuals, families, or group of people who reside within the jurisdiction of the Lodge submitting an application.

Lodge may make more than one application for Matching Relief Funds but cannot receive more than \$1,000 from this plan each Masonic year

# YOUTH SPORTS MATCHING SPONSORSHIP PLAN

The purpose for the Youth Sports Matching Sponsorship Plan is to provide supplemental financial assistance to Lodges under the jurisdiction of this Grand Lodge to encourage them to support community youth programs such as baseball, soccer, football, etc. Grants can be used for sponsorship of the team, team tournaments, or playoffs and for sponsor's signs.

Local Lodges can apply for one half of the sponsorship and tournament fee not to exceed \$500 in matching funds on a first-come, first-funded basis. Lodges can apply for one grant per year subject to the availability of funds.

### GRAND MASTER'S EMERGENCY FUND

The Emergency Fund is expended under the direction of the Grand Master for the relief of distressed worthy Master Masons, their wives, widows, children and other dependent relatives who reside in their households. The Mason upon whose membership the claim is based **must** be or have been at the time of death and for four years prior thereto, a member in good standing in a subordinate Lodge of the Grand Lodge.

Lodge must submit, as their portion of the grant, a check for one third of the amount requested from the Grand Lodge but not more than \$250. The Grand Master may contribute up to three times the amount provided by the Lodge but not more than \$750.

# **SOCIAL SERVICES**

The purpose of this plan is to assist our aging members and/or their dependents. It will allow local Lodges to identify and apply for grant (non-matching) funds to assist in providing devices or structures to allow beneficiaries to remain in their homes. This plan also assists our aging members and/or their dependents with monetary needs such as medical, prescription, utility bills, or other needs that have placed our members in financial straits.

Grant funds will be written for the amount requested by the Lodge but not exceeding \$1,500 total per Lodge on a firstcome, first-funded basis. No one individual may receive Grants totaling more than \$1,500 maximum from the Social Services Plan per Grand Lodge year.

#### EIGHT STEPS TO EXCELLENCE: BY ANDREW HAMMER PM ALEXANDRIA-WASHINGTON #22 THEOBSERVANT LODGE

The growing popularity of the idea of 'observant' Masonry has found brethren in all corners of the Craft asking the question of what exactly an observant Lodge is, and how they might go about increasing Masonic observance in their own Lodges. This document offers eight basic measures which, if observed, should result in the development of an observant Lodge. Each of these steps is either entirely consistent with Anderson's Constitutions of the Free-Masons Ithe foundational document of the Premier Grand Lodge, published in 1723 and hereafter simply referred to as the Book of Constitutions], or historical Masonic practice in North America, or both. Nothing proposed in them is alien to our Grand Lodges or their respective histories. The success or failure of these steps is entirely up to the brethren of each Lodge.

First, however, it might be helpful to offer an answer to the primary question: what exactly does one mean by 'observant'? Simply put, observant Masonry means observing the intent of the founders of speculative Masonry. That intent was not to build a mere social club or service organization. While the Craft, like any other human organization, has always been burdened by men in its ranks who subverted the purposes of the fraternity to a more mundane or profane enterprise, that was never the intent of the institution.

That intent was to build an institution that calls men to their highest level of social being, in a state of dignity and decorum, which could serve as a place for serious, mindful discourse on the lessons and meaning of life, and search for the better development of oneself. That intent means building a space where such an experience can be created, and carrying ourselves in a manner that is consistent with our highest ideals and noblest behaviors.

Observant Masons believe that by observing what the history of our Craft tells us in regard

your lodges to participate in the Child ID program within your communities. This program has been energized with a team of brethren to supply knowledge, information and supplies to the lodges for a successful and enjoyable experience for the youth and elderly of our communities. Please visit the website (www.alafreemasonry. org) for information on each of these programs. You can also contact representatives from your respective Groups or contact me and I will be more than glad to assist.

In closing Brethren, one thing I always try to impress upon a newly made Master Mason, is the importance of the symbolic meaning of wearing to that intent, we will find the optimal Masonic experience. We say observant, and speak of observance, because we seek to observe the blueprints of that intent to the best of our knowledge and ability. Even more simply, we want to do things right, and we don't want to settle for less. We want to pursue excellence in all aspects of our Masonic labor.

The eight steps offered here have proven to be successful in greatly increasing the experience of Freemasonry for brethren new and old alike. They serve as a quality control system for the operation of any Lodge, and when followed, result in a group of men who, regardless of the number of members in their Lodge, or the external nature of their temple, can find a sense of accomplishment and pride in what they have done, and who they have become. That too, is consistent with the intent of our founders.

#### Guarding the West Gate

This point is first among these, because we are nothing more or less than who we let in to our fraternity. Not every man should be a Mason, and not every man who should be a Mason belongs in just any Lodge. The brethren have a right and responsibility to determine the standards for their own Lodge, and to ask incisive questions of those men who knock on their door. Lodges should take time to first get to know the men who knock at their doors, and not simply sign any petition just because a man has an interest. Brothers who sign a petition for a man need to know who they are signing for, and more important, need to be willing to serve as his mentor. This is a fundamental point of responsibility for all brethren. Do not ask a brother in your Lodge to do the job of mentoring for you. If you are not willing to give that petitioner your time, how can you ask your Lodge to give theirs?

the white leather apron, the Badge of a Mason. In the Apron presentation in the Entered Apprentice Degree, it is explained that it is a symbol of "purity of life and rectitude of conduct," a never ending argument for nobler deeds, for higher thoughts, for purer actions. Brethren, many times we attend lodge and put on our aprons. When lodge is over, we remove it and put it back on the rack or table. I say to you this; we need to wear our aprons in our everyday lives. When we wake up in the morning, put it on (symbolically) and when we lay down to rest, remove it. Brethren, if we always wear our aprons in our everyday lives it will make us not only better Masons, but also better men.

Being Proficient in Masonic Ritual and Law Proficiency is an essential function of any observant Lodge, because we must know both what we are doing, and why, if we seek to uphold the highest standards of our respective Grand Lodges. It does no good to claim the mantle of excellence if your Lodge is not well-versed in the ritual and the Masonic law of your jurisdiction. Masonry is a thing of order, not anarchy. If you wish to keep that order, as well as harmony between your Lodge and the Grand Lodge, you must learn and follow the rules that each brother has obligated himself to observe. An observant Lodge is not a renegade Lodge. It seeks to be an exemplary one. A Commitment to Advance Brethren Through

#### the Degrees by Mutual and Genuine Effort

Progress in the degrees requires a mutual commitment of time and effort from candidate and mentor alike. Some form of proficiency, be it the catechisms, or papers delivered before the Lodge, should be required before allowing any brother to advance. Otherwise the brother learns that his advancement has no measurable value, other than his mere presence. Certainly not every man can do memory work, and not every man is a writer. But if he is not willing to even attempt to do either, then perhaps he should simply not be a Mason to begin with. The same goes for the mentor, who, though he may be experienced, must not take the easy way out when it comes to the knowledge he has pledged to impart to his apprentice.

#### The Selection and Advancement of Officers Should be by Merit Alone

This step, while admittedly difficult for some, is firmly grounded in the Book of Constitutions, without question. Masonry has never intended the adoption of a progressive line. A progressive line should only function when the next man down has the full faith and trust of his fellows that he will rule and govern his Lodge properly, because he has properly learned the requirements of his office. Of course, human nature is what it is, and mistakes can always happen, but they can be mitigated if such a standard is put in place, because no one advances until and unless they are ready to do so. The only way to justify a progressive line is if every officer is carrying his weight to the extent of his office, while at the same time preparing himself diligently to advance to the next one. Lodges ignore this step at their own risk.

#### Dressing Your Best for Lodge

How one appears before the Lodge is a sign of how much you value both the brethren and the Craft. In most lodges in the world, a dark suit and tie is the minimum required to gain admittance. It's what the brethren expect from each other in an observant Lodge, and it certainly adds to the notion that a Masonic meeting is not just another night out, but a special event, worthy of being considered as special as each of us should believe Masonry to be. Additionally, dignity expressed outwardly through dress, serves as a superstructure, helping to enhance that dignity that can only be created from within.

#### A Lodge Must Offer Quality Assemblies and Be Willing to Pay For Them

The dues of a Lodge should be set at a level which allows the Lodge to not only support and sustain itself, but enjoy a quality of experience which tells the brethren that their assemblies are opportunities to rise above the ordinary. Good meals, served at proper festive boards, are essential. The festive board conveys the sense of conviviality that helps build true brotherhood, and it is historically established in the Craft as not merely a simple dinner, but quite honestly the second half of a Lodge meeting. An observant Lodge cannot forgo it.

A Lodge must decide that Masonry is a thing of value, and properly determine that value in such a way that it allows the Lodge to work and assemble in a manner that clearly establishes that value. Our dining and social events should reflect the worth we place on ourselves. Excess is not the objective; quality is. The problem is that so many of us have forgotten what quality is to the extent that we consider any expenditure on ourselves to be pretentious. But if Masons are to be men of inner distinction, then we are fully justified in treating ourselves to the best we can afford in life. We cannot expect less from the Craft or ourselves. The Return of a Sense of Awe to Our Ceremonies

We should bring back those things that once were found in our lodges, and which helped create a very unique, contemplative atmosphere for both the candidate and the Lodge. Among these are the use of music, the manipulation of light and darkness, the Chamber of Reflection, and the closing charge which forms what is known as the Chain of Union. Consider that the candidate preparation room is not and was never meant to be a mere dressing room. Consider that the notion of a 'sacred band of brothers' might allude to a physical manifestation of that sacredness. Consider that music has always been a part of our ceremonies, and that the Book of Constitutions ends with a collection of songs. All these things are part of who we are; they are not innovations from later jurisdictions or borrowings from European Masonry. Even the use of incense is ritually alluded to in early exposures of the Craft. The idea is to stimulate and manage the sensory experience of the brethren, in the endeavor to create the sense of uniqueness one expects from a Masonic experience. Here again, there is nothing strange about employing the senses in a Masonic meeting. Our rituals teach the importance of each of those senses extensively; to not employ them in our meetings is the greater neglect and error. To refuse the restoration of awe to our rituals is to refuse to acknowledge our own heritage and history, and to deny the proper place and application of the pillar of Beauty to the Lodge.

#### Masonic Education at Every Meeting

The very origin of Freemasonry itself is in education. Whether it be the practical education in stone-cutting found in the operative craft of masonry, or the search for inner knowledge and science presented to us by the speculative Craft, the foundation of the art is inexorably based in teaching and learning. Without it, there is simply no Freemasonry taking place in a Lodge. Therefore, every meeting of the Lodge should offer some amount of Masonic education, be it through the degrees, or through presentations on the various lessons of the Craft. Even a tenminute talk focused on the symbolic meaning of a single working tool is far better than a meeting where nothing but donations, dinners, and dues are on the agenda. An observant Lodge values the educational function of Freemasonry in its full bloom; the observant Mason holds the fraternity accountable to its promise to him to bestow light, and he means to receive it from the Craft in every sense: spiritual, literal, and intellectual. Numerous monitors and manuals from our Grand Lodges, spanning over at least the last two centuries, make plain the injunction to all Masons to seek knowledge. That same injunction extends by natural progression to each Lodge, and as a result, a Lodge without Masonic education cannot be an observant Lodge, and is arguably not any kind of Lodge at all. The search for more light is at the heart of Masonry. Observance is impossible without it.

# REAL FAMILY IS THE PEOPLE WHO STAND BESIDE YOU DISTRICT NEWS & EVENTS

The formal definition of brotherhood describes a relationship between brothers or close friends, or as a man's feelings of kinship with other people. When two men have a close and loyal friendship, it is an example of being brothers.

Those of us who sit in our lodges hear the word "brother" frequently. Our founding ancestors realized the importance of the lifestyle of brotherhood and knew if men did not consider themselves brothers they would not be close to one another. And, men who are not close to one another will have little or no interest in helping with their brother member's welfare. If we cannot contribute to our needy brothers and their families what is our real meaning? Therefore, the concept of brotherhood is and has always been critical to our fraternity. Without the closeness of brotherhood we might as well be a group who simply drink coffee together.

Our lodges today continue to use the word "brother" because it is a formal part of our ritual.

We oftentimes refer to others as "brother" when we speak and shake hands. Too often we then walk away and never speak to our members until the next time we attend a meeting. Further still, we have brothers we never see or know anything about. We don't know about our brother's widows and their orphans.

Within our ritual and the teachings of our fraternity we are committed to provide brothers and their widows and orphans aid and assistance. If we do not know the circumstances of their lives, the conditions of their families or recognize their faces, then how can we live up to the standards of our obligation?

Masonry was not established as a social organization without membership commitments. It was established as a fraternity with members who were meant to be "brothers" to all members. If we do not have frequent and meaningful sincere contact with our brothers, then how can we ever live up to our obligation?

### BROTHER ROY V. "DICK" BELCHER BY JON MICHAEL TAYLOR, DGM A CORNERSTONE OF FREEMASONRY IN JEFFERSON COUNTY

On Sunday, February 23, 2019, the Brethren of Group 3, District 19 gathered together at Gardendale Lodge #907 to recognize, honor, and celebrate Brother Roy V. "Dick" Belcher on his 93rd birthday. Bro. Dick is beloved and admired throughout District 19, lefferson County, Group 3, and the State of Alabama for his dedication and commitment to the Masonic Fraternity. Throughout his Masonic career, he has helped numerous lodges across the state with degree work, installation of officers, and 50 year pin presentations. He served as District Lecturer for District 19 for over twenty years and has taught the Masonic Ritual to hundreds of brethren. He has been a prominent and influential Master Mason in lefferson County for over sixty years.

Bro. Belcher was initiated in North Birmingham Masonic Lodge #591 on July 21, 1952. He was passed to the degree of Fellowcraft on August 28, 1952 and Raised to the Sublime Degree of Master Mason on October 4, 1952. He was examined for his Grand Lodge Certificate of Proficiency, which he was awarded on October 18, 1957. He served as Worshipful Master of North Birmingham Lodge #591 in 1960-1961. He was presented the Alabama Grand Lodge Award of Gold in recognition of his 50 years of faithful service to Masonic fraternity on October 4, 2002. He served as a District Lecturer for the Grand Lodge of Alabama in different Masonic Districts for over forty years and in November, 2005, he was appointed to serve as the Right Worshipful Grand Marshall by Most Worshipful Bro. Frank Little.

I can personally attest to Bro. Belcher's commitment to the Craft. While serving as an officer and eventually Worshipful Master of Dolcito Lodge #596 in the 1990s, I called upon him often for his knowledge of the Ritual and his experience in the Fraternity. He has conducted many Masonic Funerals for our lodge and was always present for Master Mason degrees, presiding in the East for the second section of most of them. As a young Mason attempting to learn the Adopted Work, he taught me much of the ritual but the most important lesson he taught me was not the specific verbiage or Lines of March, but how to actually conduct a degree. I can remember vividly the night he told me to slow down and not "repeat" the verbiage but "confer" the degree. Mobile Police Officer Sean Tuder was killed on January 20, 2019 by a 19 year old to whom officer Tudor was serving a warrant. The police determined that the weapon used to commit the murder was a stolen weapon.

Mobile County Sheriff Sam Cochran and Mobile Police Chief Lawrence Battiste have started a public awareness campaign.

Chief Battiste stated that over 1,200 firearms were stolen in 2018. Sheriff Cochran stated that a large number of weapons making their way to the Black Market were stolen out of vehicles that were not locked. The Chief and the Sheriff are looking to reduce the number of these weapons that are falling into criminals' hands by getting the public to secure their vehicles and conceal any firearms if they are left in the vehicle.

Chief Battiste also stated that over 1,400 weapons had been recovered during 2018. Some of these weapons were stolen in a previous year. Of these weapons, only 92 were returned to their owners. The reason for this is that when the owners reported the weapons stolen, they were unable to provide a serial number for the weapon. A lot of these weapons are either sold back to the manufacturer or destroyed.

I wanted to make the brethren of the Grand Lodge of Alabama aware of this situation along with a couple of recommendations.

First, make sure you secure your vehicle when you leave it. Most criminals are looking for an easy target for theft. If you need to leave your firearms in your vehicle, be sure to conceal them. If they are visible, it makes for a more tempting target to the thieves.

Second, be sure to document your firearms by photographing them and recording the serial numbers. Store this information in a separate place from the firearms to prevent it becoming lost at the same time as the weapons. In the event that the firearms are stolen, it will allow the police to return them to you if they are recovered.

Brethren, let's take a few minutes to do some common sense things that will prevent more firearms from falling into the hands of the criminals and make it harder for law enforcement officials to do their very important job of keeping the public safe.

#### SPRING 2019 A STATE DIVIDED, BY DANIEL ROBINSON, PM TWIN CITY #76 & NOTALSULGA #119 BROTHERS UNITED

On November 24th 2018, just hours before the kickoff of the Iron bowl, I stood on the steps of Bryant-Denny Stadium in Tuscaloosa chanting, "USA, USA, USA!!" While this may not seem to be a big deal to most people, to the student veterans of Auburn University and the University of Alabama, it was. Both student veterans associations had just completed Operation Iron Ruck, a 150 mile road march from Jordan-Hare Stadium in Auburn, to Bryant-Denny Stadium. You read that correctly, 150 miles.

In the bright morning hours of Wednesday, November 21st, both universities met on the grass of Pat Dye Field to receive words of encouragement and participate in interviews from numerous media outlets. Why the 150-mile road march? Operation Iron Ruck was to serve one goal: raise awareness for the 22 veterans that commit suicide every day. Mission 22, which is a non-profit organization, serves on the front lines of raising awareness to the public for those veterans that succumb to their own personal battles every day.

Like most veterans, I am proud of my service to my country. I served in the United States Army as an Infantryman from August 2004 to March 2009. During that time, I deployed twice to Baghdad, Iraq in support of Operation Iraqi Freedom. Even after being out of the Army for 10 years, I still have vivid memories of my service and friendships that will last a lifetime.

Participating in Operation Iron Ruck was no easy task. Long movements with little to no sleep can really take a toll on the body, especially the mental aspect. I, however, did this road march for a dual cause: raise awareness for Mission 22, and for my Masonic Brothers. Veterans have a tradition of carrying either the National Flag, or their respective branches colors, during events like these. # FROM THE DESKOF

WE WANT TO HEAR FROM YOU! EMAIL SUBMISSIONS FOR THE AUTUMN ISSUE OF THE MASONIC MESSENGER BY SEPT. 1ST.

Brethren, first I want to give you an update on the new Grand View web-based database that we have implemented. The Lodge secretaries that are using it have been more than pleased with the database. They feel that it will make the secretary's job a lot easier. We do need for the secretaries to check their members addresses to be sure we have the correct address in the database. We send the Masonic Messenger to the address we have on file, so if the address is not correct, the brother's Messenger will be returned to us.

Next, I want to let you know that once again we are entering into a joint effort with the Prince Hall Grand Lodge to try to secure a sales tax exemption for both of our Grand Lodges from the State Legislature. If you know your state representative or state senator, especially if the representative is on the House Ways and Means Education Committee that controls this bill, please contact him or her for their support for HB65. We also need a State Senator to introduce it in the senate. If you know a State Senator, please ask if he or she would be willing to sponsor the bill in the senate. If we really work at this, we can make it happen.

I want to take this opportunity to remind you of the Internal Revenue Service's (IRS) requirement that each lodge file Form 990-N or e-Postcard. Any lodge failing to file for three consecutive years will lose its income tax exempt status. Filing electronically is easy. You will need your EIN number. If you do not know what it is, you can contact us here at Grand Lodge. We have the number for each lodge in the state. Do not get your own.

We also have a link on the Secretaries page on the Grand Lodge web-site. For instructions on how to file, go to our Grand Lodge website www.alafreemasonry.org and click on the Lodge Secretary Resources link. On the next page look for "IRS e-Postcard Form 990-N." That is a document with instructions on how to file. If you do not have a password, you can register as a new user. Once there, you will only need to answer a couple of questions and you will be finished.

You have four and a half months from the end of the fiscal year to file this report. Our fiscal year ends September 30th, so you have until February 15th of the next year to file. There is no penalty for filing late. However, if you lose your tax exempt status, the fee for getting it back is \$400.00 if your net assets are less than \$250,000 which includes your building. If your net assets are more than \$250,000, the fee is \$850.00. We have lodges in the state that have faced this situation, so please keep your e-Postcard current.

The final thing I want to remind you about is that it will soon be time for your lodge's Annual Communication. The Masonic Code states that officers will be elected at the regular communication immediately preceding June 24, and be installed as soon as practicable after the election, but in no case, longer than 45 days after the election. Also at this communication, you will vote on several proposed Constitution changes. We will send the proposed changes to you sometime around the end of April.

Each lodge must file all annual reports with Grand Lodge no later than August 14. A complete list of the reports may be found in Article 6-Section 21 of the Constitution and report dates in Edict 8.13 of the Alabama Masonic Code. There are five things we will need:

- 1) Your Master and Secretary (short form).
- 2) Lodge officers (long form).
- 3) Your vote on the proposed changes to the Constitution.
- 4) The Annual Report.
- 5) Grand Lodge dues.

Please remember to send these reports in on time.

**GRANDVIEW DATABASE UPDATE:** We are continuing to improve the database to meet the needs of both the lodges and the Grand Lodge. The secretary now has more options in the drop-down box for making entries when entering dues payment on a member's record. All of the Grand Lodge proceedings except for 2016 are now available for the lodge secretary to view. The bulk dues charge has been turned on so that the secretaries can prepare their member invoices. Don't forget to make sure that all of your members' addresses have been verified.

**AMITY UPDATE:** The number of Master Masons in Alabama using the Amity App continues to grow. It's great for locating lodges you want to visit and also to keep a log of those you have already visited.
